Subject: Last date of enrollment of candidates under State (CSSM) Component of PMKVY 3.0-reg

The undersigned is directed to refer to this Ministry's OM of even number dated 09.04.2021 (*copy enclosed*) wherein all States/UTs were requested to commence the training under the Centrally Sponsored State Managed (CSSM) or State component of Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0) latest by 30.04.2021.

2. In this regard, this Ministry has received multiple communications from several States regarding extension of the last date of enrollment of candidates under the CSSM-PMKVY 3.0 due to imposition of lockdowns for containing the second wave of COVID-19.

3. On reviewing the progress under State Component and after examining the current prevalent situation, this Ministry has decided to extend the last date of enrollment of candidates under State (CSSM) Component for both Short Term Training (STT) and Recognition of Prior Learning (RPL) from 30.04.2021 to 30.09.2021.

4. Therefore, all the States/ UTs are requested to strictly adhere to the above mentioned timeline of 30.09.2021 as the last date of enrollment of candidates under CSSM-PMKVY 3.0, failing which may lead to revocation of the unenrolled targets.

Subject: Extension of last date for commencement of training under Short Term Training (STT) and Recognition of Prior Learning (RPL) of Centrally Sponsored State Managed (CSSM) component of PMKVY 3.0-reg


The undersigned is directed to refer to this Ministry's OM of even number dated 15.03.2021 (*copy enclosed*) wherein all States/UTs were requested to commence the training under CSSM component of PMKVY 3.0 latest by 31.03.2021. In this regard, this Ministry received communication from several States requesting for extension of the last date of commencement of training due to re-imposition of COVID-19 lock-down, operational issues like on boarding on Skill India Portal, and Model Code of Conduct, etc.

2. Review of CSSM component of PMKVY 3.0 reveals slow progress of mobilization, batch formation and enrollment of the candidates in a majority of the States/UTs. The performance of RPL is also slow and majority of States/UTs have not yet started training. The State/UT-wise training performance under CSSM-PMKVY 3.0 as on 26.03.2021 is given at *Annexure*.

3. In view of the above and considering the requests received from several States, the last date for commencement of training under CSSM component of PMKVY 3.0 is extended from 31.03.2021 to 30.04.2021. All the States/UTs are requested to commence training under CSSM component of PMKVY 3.0 latest by **30.04.2021**, failing which may lead to revocation of targets. Consequently, the targets accumulated after revocation may be considered for allocation to the well performing States/UTs on case to case basis.

4. This issues with the approval of Competent Authority (MSDE).

Subject: Commencement of training under Short Term Training (STT) and Recognition of Prior Learning (RPL) of Centrally Sponsored State Managed (CSSM) component of PMKVY 3.0, by 31st March 2021-reg.

The undersigned is directed to refer the review meeting with States / Union Territories (UTs) on Pradhan Mantri Kaushal Vikash Yojana (PMKVY) 3.0 (2020-21) & PMKVY 2.0 (2016-20), held on 26th February 2021 under the chairmanship of Additional Secretary (Skill Development), MSDE, through video conferencing wherein it was requested to all the states/UTs to expedite process of candidates' enrolment under PMKVY 3.0. As per status on Skill India Portal (SIP) till 05th March 2021, 13 States/UTs are yet to enrol candidates under STT of CSSM of PMKVY 3.0, details of which are given at **Annexure-I**. Further, none of the states/UTs have enrolled any candidates under RPL of CSSM component of PMKVY 3.0

2. In view of the above, all the States/UTs are requested to commence training under PMKVY 3.0 latest by 31st March, 2021 falling which may lead to revocation of targets. Consequently, the targets accumulated after revocation may be considered for allocation to the well performing States/UTs.
