The undersigned is directed to refer to this Ministry's OM of even number dated 18.11.2021 and 12.01.2022 on the last date of enrollment of candidates under both the Central and State component of Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0) (copy enclosed). On reviewing the progress under various types of training, it has been observed that there is delay in various activities of the training life cycle such as assessment, certification, etc. and the progress made under different components is not at par with the expected progress.

For Customized Crash Course Programme for COVID Warriors under PMKVY 3.0 (CCCP for CW), the last date of enrollment of candidates was <u>30.10.2021</u>.
