Report of Chintan Shivir on Development of Entrepreneurship

1. Introduction

"The Government of India is implementing the National Policy for Skill Development and Entrepreneurship through the Ministry of Skill Development and Entrepreneurship to create an ecosystem of empowerment by Skilling on a large Scale at Speed with high Standards and to promote a culture of innovation based entrepreneurship which can generate wealth and employment so as to ensure sustainable livelihoods for all citizens in the country."

The entrepreneurship policy framework has been developed to address the following objectives:

- Educate and equip potential and early-stage entrepreneurs across India
- Connect entrepreneurs to peers, mentors and incubators.
- Support entrepreneurs through Entrepreneurship Hubs (E-Hubs).
- Catalyze a culture shift to encourage entrepreneurship.
- Encourage entrepreneurship among under-represented groups.
- Promote Entrepreneurship amongst Women
- Improve ease of doing business.
- Improve access to finance.
- Foster social entrepreneurship and grassroots innovations

The policy links skills development to improved employability and productivity in paving the way forward for inclusive growth in the country. The skill strategy is complemented by specific efforts to promote entrepreneurship in order to create ample opportunities for the skilled workforce.Gradually there has been an accent on promoting entrepreneurship with the purpose of channelizing resources, arresting unemployment and creating wealth.

Promoting entrepreneurship provides a platform for young individuals to harness their potential, creativity, and energy. By supporting the entrepreneurial aspirations of the youth, we can capitalize on their innovative ideas leading to sustainable growth and development. Entrepreneurship can empower women, marginalized communities, and individuals from economically weaker backgrounds to participate in economic activities, break barriers, and achieve financial independence.

The Ministry of Skill Development and Entrepreneurship (MSDE) is an integral part of the government policy on "Sabka Saath, Sabka Vikaas" and is committed to overall human resource development to take advantage of the demographic profile of our country's population in the coming years.

MSDE has taken a number of initiatives for entrepreneurship generation and promotion through its Autonomous agencies National Institute for Entrepreneurship and Small Business Development (NIESBUD) and Indian Institute of Entrepreneurship (IIE). Both bodies of MSDE have proved to play a pivotal role in building an entrepreneurial ecosystem not only in India but also in other countries through training and development programmes. Since inception, NIESBUD has provided training to 13,43,426 trainees as of March 31, 2023 through 50719 different training programme categories focused on areas of stimulation, support and sustenance of entrepreneurship development including 5317 international participants hailing from more than 145 countries throughout the globe.IIE has provided training to 2,92,371 trainees through 8661 programmes since 1994-95 (year of incorporation).

NIESBUD under the MSDE has also collaborated with United Nations Development Programme (UNDP), National Institute of Rural Development and Panchayati Raj (NIRDPR) and Tata Institute of Social Sciences (TISS) and jointly developed curriculum on Mentorship. The MSDE has focused not only on trainings but also on providing mentoring and handholding support to the trainees, facilitating their journey from aspiring entrepreneurs to accomplished entrepreneurs. Nonetheless, a concerted effort is required for emphasising the promotion of micro and small entrepreneurs in India who rather than seeking jobs, become job creators resulting in accelerated national growth.

The Ministry of Skill Development and Entrepreneurship organised the Chintan Shivir on Development of Entrepreneurship, aimed at fostering the growth and development of entrepreneurship in India on 17th July 2023 at Kaushal Bhawan, Moti Bagh, New Delhi. The Shivir brought together various stakeholders, including Central Ministries, State Governments, organizations, institutions, financial institutions, and entrepreneurs, to collaborate and create a unified approach towards promoting entrepreneurship. The objective was to establish common principles and guidelines for promoting entrepreneurship, ensuring a cohesive and synergistic ecosystem for nurturing entrepreneurs. The Shivir also discussed innovative business models,

emerging technologies, and disruptive trends that are shaping the entrepreneurial landscape. The focus was on identifying strategies and best practices to support and foster new age entrepreneurship to generate actionable insights, recommendations, and best practices that can support entrepreneurs and stakeholders in navigating the evolving landscape of new age entrepreneurship. Chintan Shivir seeked to identify gaps, share best practices, and create a collective vision to boost the entrepreneurial ecosystem so as to bring about convergence and avoid duplication of efforts in this area. 2. Objectives

The key objectives of the Chintan Shivir on Development of Entrepreneurship were as follows:

- a) Facilitate Collaboration: Provide a platform for stakeholders to collaborate, exchange ideas, and identify opportunities for synergy among different entrepreneurship development initiatives. It is very important to create network of networks to cater to needs of entrepreneurship.
- **b**) **Streamline Methodologies:** Analyze existing methodologies and practices of entrepreneurship initiatives to identify areas for improvement and innovation. It is imperative to note that the analysis of methodologies with respect to entrepreneurship training techniques and pedagogy as per the current requirements may be useful for the different target groups.
- c) Institutional Arrangements: Examine the institutional setup of various entrepreneurship organizations including educational institutions providing entrepreneurship education and propose measures to enhance their effectiveness and coordination. Analyzing importance and maximizing impact of incubators and accelerators in academic institutions. The creation of Institutional arrangements may help in creating synergies among the enablers.
- d) Inclusive Approach: Ensure that the principles and guidelines formulated consider the needs of diverse entrepreneurs, including women, rural entrepreneurs, marginalized communities, and geographies with special focus on aspirational and LWE districts,

vibrant villages, North - East region, and border areas. There is a strong need to address the challenges faced by the target groups and the specific strategies may be proposed.

- e) Identify Challenges: Identify key challenges faced by entrepreneurs at different stages of their journey, including ideation, funding, scaling, and sustainability. Appropriate measures may be formulated based on the challenges faced by the first generation entrepreneurs.
- **f) Share Best Practices:** Facilitate the exchange of best practices and success stories from various entrepreneurship ecosystems, both within India and globally.
- g) Policy Formulation: Engage policymakers and regulatory bodies to identify areas for policy intervention and reforms that can support entrepreneurship development and bring about convergence. Support necessity driven entrepreneurs, and encourage innovation-driven and opportunity driven entrepreneurs with the policies and schemes.
- h) Access to Finance: Explore mechanisms to improve access to finance, including venture capital, angel investments, and innovative funding models. There is a strong need to identify the challenges and to propose solutions for ease of doing business.
- Access to Market: Explore possibilities for nano and micro entrepreneurs to tap the market. It is very important to connect the nano and micro entrepreneurs to market including digital platform.

5. Plenary Session

5.1 Inauguration

The Chintan Shivir was inaugurated in the auditorium of Kaushal Bhawan by Shri Dharmendra Pradhan, Hon'ble Minister in the Ministry of Skill Development & Entrepreneurship and Education in the presence of Guest of Honour, Shri Rajeev Chandrasekhar, Hon'ble Minister of State in the Ministry of Skill Development & Entrepreneurship and Electronics and Information Technology and Shri Atul Kumar Tiwari, Secretary, MSDE. MS. Hena Usman, Joint Secretary, MSDE, extended a warm welcome to all the esteemed dignitaries and delegates at the Chintan Shivir.

The Minister further highlighted that skill development and entrepreneurship are intertwined, and the Ministry is committed to creating a seamless ecosystem that bridges the gap between skill acquisition and enterprise creation.

The Hon'ble Minister expressed his belief that the Chintan Shivir is a significant step towards reinforcing their commitment to entrepreneurship development. He urged all stakeholders to actively participate and come up with presentations on the way forward for promoting entrepreneurship. By harnessing the collective wisdom and expertise of the participants, the Shivir will play a crucial role in shaping a robust and inclusive entrepreneurial ecosystem in our country.

6. Breakout Sessions

The whole Chintan Shivir was divided in three breakout sessions:-

6.1. Breakout Session – 1: Strengthening Entrepreneurial Ecosystem in the country

The Break out session on – "Strengthening Entrepreneurial Ecosystem in the country," was chaired by Ms. Sonal Mishra, Joint Secretary, MSDE and Co-Chaired by Ms. G. Madhumita Das, Joint Secretary & Financial Adviser (JS & FA), MSDE. The list of the participants is placed at *Annexure-3*.



Breakout Session 1

After a brief welcome speech, Ms. Sonal Mishra, Joint Secretary, MSDE kick started the session by laying the objectives of the breakout session. This was followed by a presentation by Ashutosh Kumar, Deputy Secretary, about the various topics to be covered during the session. The same have been listed below.

- Creating a vibrant entrepreneurial ecosystem for supporting the aspiring and existing entrepreneurs from rural and urban areas, including LWE districts, aspirational districts, Vibrant Villages, North-East region, borders areas, etc.
- 2. Promoting and Strengthening women entrepreneurship
- 3. Creating an enabling policy environment for entrepreneurship

Ms. Sonal Mishra, Joint Secretary, MSDE invited the expert from different Ministries to place their view points on the thematic areas of breakout session.

Director, Ministry of Tribal Affairs talked about the 178 tribal districts and methods to make them function well under livelihood scheme. She focused on the problems faced by the tribal artisan & entrepreneurs which includes lack of marketing knowledge and inability of not being able to produce according to the market demand.

She highlighted the problem of credit which is a major challenge faced by the tribal entrepreneurs and artisans. She briefed about 1340 operational Van Dhan Vikas Kendras (VDVKs), an initiative targeting livelihood generation for tribal gatherers and transforming them into entrepreneurs. She further suggested that the MSDE may come up with special NSQF norms for the tribal entrepreneurs and artisans. This would enhance the credibility among the customers. In order to have convergence among the Ministries, she suggested that there should be a tie up with the MSDE & Agriculture Department regarding Agro-Forestry products.

The discussion was further taken forward by Ms. Sonal Mishra, Joint Secretary, MSDE, as she invited Joint Secretary, Ministry of Housing & Urban Affairs (MoHUA) to present his view points with the group.

The Joint Secretary, MoHUA talked about the Prime Minister Street Vendor's Atmanirbhar Nidhi (PM SVANidhi) and how it helped street vendors affected due to COVID-19 Pandemic, by providing them micro-credit facilities by linking them with financial system under the scheme. The vendors, availing loan under the scheme, are eligible to get an interest subsidy @ 7% on timely repayment. He suggested to focus on entrepreneurship development programmes for 18 Lakh street vendor mapped so that they can be on boarded in the formal economy sector and could be connected to various other Schemes of the Government. He emphasised on digital adoption and promotion amongst various street vendors so as to make them knowledgeable to compete in the market.

Further after the experts had weighed in on the subjects, Sonal Mishra, Joint Secretary, MSDE invited opinions from different stakeholders and she encouraged them to engage with the experts. There were a lot of suggestions that came forward which included thoughts on women entrepreneurship, challenges the entrepreneurs face in rural areas, marketing linkage and credit facilities. The training related to widows of Ex-servicemen and to develop a model where more and more ex-servicemen can take entrepreneurship as their career was a suggestion raised by DGR officials.

Officials from Laghu Udyog Bharati, suggested that there should be more skill development training programmes in manufacturing sector as the current focus is on service sector which is clearly visible from the number of unicorns coming from service sector in India.

Deputy Secretary, Ministry of Textiles described about the SAMARTH (Scheme For Capacity Building In Textile Sector) which caters to provide demand-driven, placement oriented skilling programme to incentivize the efforts of the industry in creating jobs in the organized textile and related sectors to promote skilling and skill up-gradation in the traditional sectors and to provide livelihood to all sections of the society across the country. It was discussed that as MSDE focuses on various sectors of skilling, convergence with the SAMARTH scheme could be highly beneficial.

Jan Shikshan Sansthan (JSS) officials suggested to open more Incubation Eco-System in Rural areas, to provide assistance and initial push to the beneficiaries of JSS.

Deputy Director General, DGT- MSDE informed that their department is adapting itself with the changing scenario of skill eco-system for which they are upgrading their course and curriculum.

Representatives from YuWaah-United Nations Children's Fund (UNICEF) briefed about their platform of Passport To Earning (P2E), an e-learning solution to empower India's young people with Skills and abilities to thrive in school, work and life. The platform provides skilling and learning opportunities to enable new, continuous access to skilling, re-skilling, and up-skilling requirements of young people across India through online training, blended learning models, and offline engagement. They also described about their digital aggregator platform which consolidates the journey of entrepreneurs.

Representatives from NITI Aayog described about the Women Entrepreneurship Platform (WEP). They described that training, skilling, technical assistance, mentoring and handholding support are the key areas of the platform. They have mapped around 400 State Schemes and 70 Central Government Schemes for the same.

EDII representative focused on certification based training and added that skillpreneurship and skilling will add value to the entrepreneurs. EDII described that they have worked in 22 States across the country.

The breakout session concluded with summing up by Ms. G. Madhumita Das, JS & FA where everyone agreed that there should be more focus on entire life cycle of entrepreneurship and such regular interactions with different stakeholders should continue in future for promoting entrepreneurship.

A brief presentation was given on Breakout Session-1 which is placed below:

Presentation 1: Strengthening Entrepreneurial Ecosystem in the country

Breakout Session 2

Shri Nilambuj Sharan, Senior Economic Advisor, MSDE welcomed the dignitaries from Ministries, financial Institutions, Institutes and entrepreneurs in the break out session. He started the session by laying the objectives and aims of the breakout session. The session focused the discussion on following topics :

- 1. Access to Credit Finance to Nano and Micro entrepreneurs
- 2. Convergences of skilling with credit finance
- 3. Lowering the cost of lending
- 4. Interest Subvention for NBFC and Nano entrepreneurs
- 5. Developing a support Ecosystem for entrepreneurship through incubators and accelerators.

Ved Mani Tiwari, COO, NSDC shared his views on above mentioned points and invited the experts to share their views.

Dr Ranade, V.C shared his views in brief about the payments delay problem of entrepreneurs and how the delays in the payment may be reduced and gave suggestion like Udhyam registration, Digitalization, Organizing Hackathon, Developing ARP Apps and MSME may push B to B lending. The CGM, Small Industries Development Bank of India (SIDBI), shared his views about Ease to finance through CGSTM scheme, Udhyam registration, Udyami Assist Platform, Udhyami Mitra for credit linkages and told how ONDC may be leveraged for market linkages. He shared his experience about soft skills training imparted by them and got successful outcome. He talked about the Nano Incubators & accelerators – SIDBI.

The CEO, National Credit Guarantee Trustee Company Ltd (NCGTC) talked about the payment delay and Startup and Standup scheme of the government and told about the loan and facilities given under these schemes. He suggested about invoice discounting.

CGM, State Bank of India stated that the Rural Self Employment Training Institute (RSETI) is providing the trainings and thereafter the banks are providing the loans to the prospective participants. Further, he briefed that there are various branches of SBI especially for the support of Startups. He suggested that central based skilled youth data should be formulated and linked with the financial institutions.

The Director, Indian Institute of Entrepreneurship shared his experiences of the North Eastern Region (NER) and briefed about the financial and marketing problems faced by the entrepreneurs in NER. He further suggested that remedy to the problem can be ease to finance along with marketing and logistic support could help the budding entrepreneurs of the region.

The Programme Manager, META shared their experiences on ways META is providing skilling to the youth and thereby linking them with the digital platform. He informed that they have created innovative credit model for enabling the finance to small businesses.

The CGM, Indian Bank gave insights on ways their banks are providing the finance to the budding and existing entrepreneurs. Further, to which he added that the empowerment of an entrepreneur is the need of the hour.

The officials from SAMADHAAN, Ministry of Micro Small and Medium Enterprises (MSME) shared that they are having a digital training module, wherein the trainees may take the training digitally in which they will be provided mentoring and handholding support for setting up their enterprises. The trainees through digital training module are taught about financing and marketing.



Presentation by Breakout Group

At the end, the breakout session was then summed up with issues to be addressed like Nano Entrepreneurs facing the problem in getting the finance, cost of lending required to be reduced, interest subvention required for both NBFC & Nano entrepreneurs, digital platform required for training & mentoring support and most importantly the Support Ecosystem for entrepreneurship be developed.

A brief presentation was given on Breakout Session-2 which is placed below:

Presentation 2: Fostering Financial, Marketing, Digital Linkages and Compliances for Enterprises

Access to Credit

- 1. Skill Loans Guarantee Scheme Higher value, NBFCs, MFIs
- 2. Modification in existing credit Guarantee Schemes to facilitate journey from skilling to enterprise setting

Cost of Credit

- 1. Lowering Cost of lending to NBFC and MFIs through repeat guarantee scheme of CGSMFI
- 2. Interest subvention- for both NBFC and Nano Entrepreneur

Ecosystem for Entrepreneurship

- 1. Nano Enterprise Incubators and Accelerators SIDBI
- 2. Udyami Assist Platform for formalization
- 3. Udyami Mitra for Credit linkage
- 4. Skill India Digital and RSETI Integration
- 5. Digital platform for entrepreneurship training and handholding
- 6. Leveraging ONDC for market linkages

6.3. Breakout Session – 3: Capacity Building, Mentoring and Handholding

The Breakout 3 was chaired by Dr K K Dwivedi, Additional Secretary, MSDE and Co-Chaired by Ms. Trishaljit Sethi, Additional Secretary / Director General (Training), MSDE. The list of the participants is placed at *Annexure-5*.



Breakout Session 3

Dr K K Dwivedi apprised the participants about the broad areas to be discussed in the breakout room comprising the following:-

1. Effective training programs for developing entrepreneurial skills and making entrepreneurship education application oriented with different training techniques and

pedagogy and the need to establish difference between management education and entrepreneurship education.

- 2. Standardization and Embedding of entrepreneurship in education.
- 3. Institutional Network, Mentoring and Handholding Process.
- 4. Leveraging emerging technologies (AI, blockchain, IoT) for entrepreneurial growth.

Dr Dwivedi stressed that people need to be exposed to success stories to inspire them to become entrepreneurs.

Ms. Trishaljit Sethi acquainted the participants about the efforts being undertaken by the MSDE to promote entrepreneurship through its autonomous institutions NIESBUD and IIE. Thereafter, the breakout session was open to suggestions from the participants on the thematic area.

The CEO, deAsra Foundation stressed that entrepreneurial mindset can be inculcated through education, exposure and experience. She added that the faculties need to be capacitated to guide the trainees. Community and parents should also be involved in counseling to create entrepreneurial environment. She indicated that Artificial Intelligence maybe used to share resources and collaborate between the institutions.

The Director, Uttar Pradesh Skill Development Mission (UPSDM) shared that the Priority Sector Lending (PSL) does not talk about young entrepreneurs. The PSL should be linked with first generation entrepreneurs. He stressed that we are taking initiatives for entrepreneurship development but in silos. The initiative should be led centrally and collectively. Further, he pointed that entrepreneurship education should be institutionalized at school level.

Dr K K Dwivedi cited that Credit and financial linkages are the main challenge among the first generation entrepreneurs. If an idea is not funded, it will eventually die.

The Senior Adviser, NITI Aayog expressed that we talk about collaboration but we hardly collaborate. We need to have a hub and spoke model for promoting entrepreneurship. She apprised about the Women Entrepreneurship Platform (WEP) developed by NITI Aayog which is a unified access portal bringing together women from different parts of India to build a nurturing ecosystem that enables them to realize their entrepreneurial aspirations.

The CEO, Odisha Skill Development Authority (OSDA) stressed that we need to make the schemes more acceptable for people at ground. He expressed that entrepreneurial mindset should be inculcated from day one in the ITI and Polytechnics. Further, he talked about having clear exit policy for startups.

Dr K K Dwivedi expressed that we should create an enabling and empowering ecosystem where the entrepreneurship culture should flourish.

The CEO, Beauty & Wellness Sector Skill Council (B&WSSC) shared that 55% trainees in beauty and wellness pursue entrepreneurship as their career option. The span of a trainee doing job is only for 2-5 years, eventually they also go for self employment. She emphasized that the trainees should be given exposure to entrepreneurship within their institutions along with skilling. She focused that entrepreneurship education should be made a part of skilling curriculum. She further shared that the Skill training certificate should be recognized for financial linkage.

Representative from Food Processing SSC expressed that every district has an identified product and the resources are available at the district level. Common facility for capacity building may be developed at district level and the resources may be leveraged to create brands at district level.

The Associate Director, Sa-Dhan Microfinance shared that the micro finance institutions have a strong presence in the rural areas. Their line officers may be capacitated to promote entrepreneurship in rural areas.

The CEO, Life Science SSC expressed that there should be one stop platform to connect for getting guidance on entrepreneurship.



Brief on presentation by Dr K K Dwivedi, Additional Secretary, MSDE

Dr K K Dwivedi concluded the discussion by emphasizing the importance of effective training programs for developing entrepreneurial skills and embedding entrepreneurship in education. The need to adopt application-oriented training techniques and pedagogy was also highlighted. The session also focused on the role of institutional networks, mentoring, and handholding in supporting entrepreneurs throughout their journey. The integration of emerging technologies such as AI, blockchain, and IoT for entrepreneurial growth was explored to drive innovation and efficiency.

A brief presentation was given on Breakout Session-2 which is placed below:

Presentation 3: Capacity Building, Mentoring and Handholding

Entrepreneurship Training Delivery

- Enhance industry engagement by inviting successful entrepreneurs and industry experts
- Educate participants about various funding options available for startups, such as government grants, angel investment, venture capital, and crowd funding
- Provide guidance on how to prepare a compelling business plan and pitch to attract investors

- Setting up nano incubation centre in every block and district level which can act as one stop solution and common services centre for entrepreneurship development
- Integration with existing network of start-ups with these incubation and accelerator centres

Standardization and Embedding of Entrepreneurship in Education and Skilling Ecosystem

- Collaboration with Stakeholders like Government, Industry, and Academia
- Developing standardized entrepreneurship curricula, assessment and certification that can be integrated into educational and skilling institutions
- Capacity building of faculties on entrepreneurship to encourage multidisciplinary approaches to problem-solving and innovation
- Integrate entrepreneurship as a core subject in curricula from primary to higher education and skilling levels to expose students to entrepreneurial concepts, skills, and mindsets early on, fostering a culture of innovation and risk-taking
- Recognize and celebrate successful entrepreneurs who have made a positive impact on society

Leveraging Emerging Technologies for Entrepreneurial Growth

- Create a platform for aspirational entrepreneurs to link and map for services of mentoring and handholding
- Channelizing the benefits of social media as a business platform and marketing (aggregating client feedback for forward linkages and improvement in service and product delivery)
- Creating B2B platform for entrepreneurs through support of Government and Industry

Institutional Network, Mentoring and Handholding Process

- Create a bespoke approach for entrepreneurship for breaking the silos and enhancing convergence at a functional level
- Mentoring

- Crete a robust mentoring ecosystem and facilitate peer-to-peer mentoring through industry partnership
- Promote voluntary mentorship by identification of relevant mentors from aspirational institutions like IITs, IIMs, etc.
- Creating mentor boards at hyper local level to support entrepreneurship development at village level
- Comprehensive handholding program for assisting entrepreneurs in business planning, market entry, access to finance, marketing strategies, legal compliance, and scaling up
- Linking Priority Sector Lending to young and budding entrepreneurs especially for agriculture sector
- Rethink the regulatory framework for flexibility and ease of doing business eg: easing the clause for collaterals against credit
- Innovative financing Government can create a fund of funds and provide interest subvention
- Recognition of skill certificate by financial institutions for credit linkages
- Supporting and strengthening Self Help Groups ecosystem for entrepreneurship development which will also facilitate inclusion
- Creating a Mentor of Mentors System: Capacity building of line managers of micro finance institutions to reach more entrepreneurs

7. Recommendations

Following recommendations emerged from the Chintan Shivir on Development of Entrepreneurship:

7.1. Strengthening Entrepreneurial Ecosystem in the Country

- a) Create a vibrant and convergent entrepreneurial ecosystem that supports aspiring and existing entrepreneurs from all regions, including rural and urban areas, LWE districts, aspirational districts, vibrant villages, North-East region, and border areas.
- b) Promote and strengthen women entrepreneurship through targeted initiatives, mentorship programs, and access to finance.
- c) Foster an enabling policy environment for entrepreneurship by implementing regulatory reforms that simplify procedures, reduce bureaucratic hurdles, and promote ease of doing business.
- d) Establish platforms for collaboration and knowledge exchange between different stakeholders, including government agencies, financial institutions, industry experts, and academia, to create a unified approach towards nurturing entrepreneurship.
- e) Create a network of networks by leveraging existing resources is an effective approach to promote collaboration, knowledge sharing, and collective action among diverse stakeholders.
- f) Entrepreneurship should be embedded in various schemes of other Ministries as a part of skilling.

7.2. Fostering Financial, Marketing, Digital Linkages, and Compliances for Enterprises

- a) Improve access to credit finance for nano and micro-entrepreneurs, especially those from marginalized communities and underrepresented sectors, by promoting financial inclusion and creating customized financial products.
- b) Facilitate convergence between skill development and credit finance by developing seamless linkages between training programs and financing opportunities to support aspiring entrepreneurs in turning their skills into viable enterprises.
- c) Introduce interest subvention schemes for NBFCs and nano-entrepreneurs to lower the cost of lending and encourage more entrepreneurs to access formal credit facilities.
- d) Develop a robust support ecosystem for entrepreneurship by establishing incubators, accelerators, and digital platforms that provide mentorship, guidance, and market linkages to start-ups and small businesses.

e) Regular meeting with various stakeholders should be conducted to streamline the process of schemes/project implementation and to come up with remedies to their problems.

7.3. Capacity Building, Mentoring, and Handholding

- a) Revamp training programs to focus on developing practical entrepreneurial skills, including critical thinking, problem-solving, financial literacy, and market research.
- b) Embed entrepreneurship in the education system at all levels monitored by the MSDE, from schools to institutes of higher learning, to instill an entrepreneurial mindset among students and encourage them to pursue entrepreneurship as a viable career option.
- c) Strengthen institutional networks, mentoring, and handholding processes to provide ongoing support to entrepreneurs, including access to technical expertise, market insights, and networking opportunities.
- d) Actively engage with grassroot entrepreneurs and local communities to understand their unique challenges and aspirations to design targeted support program Empowering grassroot entrepreneurs will not only uplift local economies but also contribute to the overall economic growth and development of the nation.

- e) Leverage emerging technologies such as AI, blockchain, IoT, and digital platforms to enhance the delivery of entrepreneurship training, mentorship, and business development services.
- f) Schemes/projects for promotion of Entrepreneurship should be undertaken in vibrant villages also for collective growth.

The Chintan Shivir on Development of Entrepreneurship brought together diverse stakeholders to collectively work towards fostering entrepreneurship and unleashing the potential of our nation's entrepreneurial talent. The above recommendations represent the consensus reached during the breakout sessions, reflecting our commitment to create an enabling ecosystem that nurtures and supports the growth of entrepreneurship in India.

The Chintan Shivir on Development of Entrepreneurship proved to be a valuable platform for knowledge exchange, collaboration, and strategy formulation. The discussions and insights generated during the breakout sessions will serve as a foundation for policy recommendations and initiatives to create a thriving entrepreneurial ecosystem in India.



Way Forward by Secretary MSDE

8. Way forward (Agenda for next three months):

- Entrepreneurship centres across the country should be mapped under PM Gati Shakti.
- Development of Entrepreneurship Development Centres (EDCs) in ITIs across the country.
- Tie up with IITs and IIMs for developing of EDCs or leveraging their existing EDCs.
- Convergence with various central schemes- PM-SWANidhi, Rural Self Employment Training Institutes (RSETIs), Samarth (Scheme for Capacity Building in Textile Sector) within existing system on priority basis.
- Regular meeting with various stakeholders should be conducted on a fortnightly basis to streamline the process of schemes/project implementation and to come up with remedies to their problems
- Schemes/projects for promotion of Entrepreneurship should be undertaken in vibrant villages also for collective growth
- Projects on training/up-skilling for promotion of tourism, health sectors, textile, street vendors should be collectively taken up.
- Organisations should come up with innovative ideas for enhancing digital literacy about skilling, entrepreneurship and marketing.
- Convergence with Ministries/Organisations having training, skilling and entrepreneurship development programs specifically designed to empower women entrepreneurs.
- Beneficiaries of entrepreneurial ecosystem should be made aware of various schemes and initiatives taken by Government for ease of taking loans and credits for running enterprises through proactive advocacy and convergence with other Ministries.
- MSDE to come up with a Scheme for entrepreneurship development focusing on setting up entrepreneurship centres or supporting the already existing centres in educational and skilling ecosystem. The scheme should include setting up nano incubation centres at block and district level and capacity building of faculties and trainers on entrepreneurship among other entrepreneurial support activities.
